Established 1979, Marin City Community Development Corporation (aka CDC) is a nonprofit 501(c)(3) organization and located in the heart of Marin City (United States Census Bureau-Census Tract 1290) and provides critical and essential workforce, mental health, and financial educational services to marginalized, low-income, and underserved communities.

"Our mission is to enhance social, economic, and climate justice for underserved, marginalized, and low-income people through employment services, mental health, and education."

The work of the CDC is for all of the residents of Marin City and Marin County.

Empowerment Clubhouse Program addresses both the health and social needs of Members through an integrated model that connects physical clubhouse-where Members are engaged in an innovative therapeutic community rooted Social Practice (Work-Ordered-Day/WOD) and take steps in reclaiming their agency and dignity. The Empowerment Clubhouse is a no cost membership-based social/vocational community where people living with persistent mental illness come to rebuild their lives; WOD's on weekdays to build upon strengths and abilities and a place to socialize in the evenings and weekends.

Workforce and Career Development Program provides job readiness, life skills, and placement assistance and includes wrap around services and referrals to State of CA DOR and other programs.

Construction Trades Laborer's Pre-Apprenticeship Program provides essential and required education and hands-on training for individuals 18 years and older with qualifications to become employed at the Laborer's Union. Program is in partnership with the Northern California Laborer's Training Center (norcaltc.org) and LiUNA.org.

PowerUP Youth Program (PUYP)-Effective July 2024, the PUYP replaced the former Summer Youth Empowerment Program. Youth receive yearlong support and resources for part-time job training and placement, career exploration, life skills, community activities, college preparation and support, professional development, public speaking, special projects American Climate Corps Application Assistance, and eco-friendly activities and projects, i.e., gardening and climate change for the future.

State of California Department of Rehabilitation (DOR) Employment Services-Since 2011, the CDC has been providing vocational services to eligible residents with physical and/or mental health in Marin County. Services include workplace assessment & evaluation, job searching & preparation, training, coaching, and placement are helping disabled and impaired members of our community find meaningful, lasting employment and be seen as the valuable individual contributors that they are to our society.

Small Business Program aka Micro Enterprise Program-Provides resources, workshops, and training to existing and upcoming generations of entrepreneurs; adding prosperity and bright futures for low-income individuals who never thought they could be 'their own boss' and the opportunity to leave legacies for their families.










The Construction Trades Laborer's Apprenticeship Program provides hands-on training and education to underserved, lowincome, and marginalized individuals 18 years and older. Many individuals face obstacles, have mental health, and life experiences that have forced them into long periods of unemployment. Others have experienced generational poverty, have limited education, are on probation/parole. The CDC is grateful to their funders and partners offer this life-changing program that creates self-sufficiency, equitable income, and fresh bright futures; where no one gets left behind.

With the rise in mental health, and to support women and youth in construction trades, the CDC is expanding the CTP services in 2025. Call us to learn more!



Mental Health in Construction Stats That Might Surprise You

According to the <u>Centers for Disease Control</u>, construction has the highest suicide rate of all industries, at 53.2 suicides per 100,000 workers. That's about four times greater than the national average (17.3/100,000) and five times greater than all other construction fatalities combined (10.1/100,000).



"DOR administers the largest vocational rehabilitation and independent living programs in the country. Vocational rehabilitation services are designed to help job seekers with disabilities obtain competitive employment in integrated work settings. Independent living services may include peer support, skill development, systems advocacy, referrals, assistive technology services, transition services, housing assistance, and personal assistance services."-dor.ca.gov

As an accredited organization through the Commission on Accreditation of Rehabilitation Facilities (CARF.org); our person-centered services approach, and in close collaboration with DOR standards, places individuals at the center of what we do. Individuals are part of the process to create their customized Individual Service Plan (ISP) designed to build and enhance their career goals that ultimately benefit their personal lives. 
